# FREE ECONOMIC ZONE (FEZ) IN SYUNIK REGION

#### FOREWORD

The main goal of the Free Economic Zone (FEZ) is to contribute to the export volume growth and creation of new workplaces, as well as ensure sustainable economic development through integrating foreign direct investments and introducing advanced technologies.


An appropriate legal framework has been established to ensure the operation of free economic zones. With this regard, the Law of the Republic of Armenia (RA) "On Free Economic Zones" adopted on May 25, 2011 by National Assembly of Armenia is a basic regulatory document. Aimed at providing tax and customs preferences prescribed by this Law, relevant amendments have also been introduced to other related laws. Activities of FEZ are regulated also by Government decree 1521-N.

To foster regional economic cooperation and for further development of the national economy, growth of the export volumes the Armenian Government has decided to initiate the establishment of Free Economic Zone in the province of Syunik which is situated at the border with Iran.

## TRADE REGIMES OF ARMENIA

- Since 02.01.2015 Armenia is a member of the Eurasian Economic Union (EEU), which creates the following opportunities:
  - Access of Armenian production to about 180 million consumers.
  - Duty free import of raw materials from EEU member states.
  - No customs formalities during mutual trade between EEU member states, which leads to financial costs reduction and time-consuming for business.
  - No non-tarif measures of trade and trade technical bariers between EEU member countries.
  - Favorable import tarifs for about 750 products.
- Free trade agreements with CIS countries, which gives duty free access to 250 million consumers.
- Armenia currently enjoys "Generalized system of preferences" of the USA, Canada, Switzerland, Norway and Japan.
- 4. Armenia is one of the countries enjoying "Generalized system of preferences" (GSP+) provided by the European Union.
- 5. Bilateral treaties on investment promotion and protection with over 40 countries. Investors of the Contracting parties are granted a number of guarantees, in particular fair and equitable treatment, protection from expropriation, free transfer of means and full protection and security, an alternative dispute resolution mechanism is allowed.
- 6. Membership to the International Centre for Settlement of Investment Disputes.

# THE PROCEDURE OF BECOMING FEZ ORGANIZER

## Documents for the process:

- 1) Application,
- 2) List of services and tariffs provided by the organizer,
- 3) Free economic zone outline, establishment goal, main activities,
- 4) Location, site plan, and building design as well in case of buildings,
- 5) Business plan.

#### FEZ PREFERENCES:

- FEZ organizer and operator (hereinafter resident) are exempted from VAT when delivering services and supplying goods in FEZ territory;
- Legal entities are exempted from profit tax when being a resident and performing activities in FEZ;
- Public and industrial buildings and structures that belong to or are used by FEZ residents in FEZ territory are exempted from property tax;
- Services delivered in the free economic zone on behalf of the state bodies are realized on "one stop shop" basis.
